Building Permit Requirements

Please ensure the following required items are included in the packet with your completed Building Permit Application, and checked off before submission. Packets missing any items will be returned, and reviewed according to the time of re-submission.

- ☐ One copy of the deed to the property.
- ☐ One Copy of Current Property Survey by Certified Licensed Surveyor.
- ☐ Two copies of the RES Check.
- ☐ Two copies of structural engineering, if required by plans examiner at time of plan check. **(PDF Required)**
- ☐ Read and sign the Wastewater Connection, Water Connection, and Owner/Builder Form.
- ☐ Obtain and submit Performance Guarantee Bond for any and all utility line excavation/installations in City Street or Right-of-ways.
- ☐ Excavation Inspection Checklist Complete/Pre-Construction Meeting with Permit Coordinator.
- It is the applicant's responsibility to set up meeting with Eureka City Permit Coordinator by calling 435-433-6915.**
- ☐ One copy of Soil Sampling Results, if needed.
- ☐ One copy of soils engineer's report verifying soil prep to meet subdivision Geo-Technical report, required at footing inspection.
- ☐ Two copies of site plan which must show the following:
 - ☐ North arrow & scale of site plan
 - ☐ Property line & dimensions
 - ☐ Existing curb, gutter & sidewalk
 - ☐ Existing easements
 - ☐ Existing utilities
 - ☐ Existing Irrigations ditches
 - ☐ Minimum setbacks per plat or zoning requirements
 - ☐ Driveways 30' from corner
 - ☐ Clear view area for corner lots
 - ☐ Proposed building with dimensions to property lines
 - ☐ Proposed utilities
 - ☐ Existing buildings on property, if any
- ☐ Two copies of the building plans.
 - ☐ Footing & Foundation Plan, 1/4" = 1'0"
 - ☐ Floor Plan, 1/4" = 1'0"
 - ☐ Framing Plans, 1/4" = 1'0"
 - ☐ Electrical layouts
 - ☐ Floor and roof framing plans, with all structural members identified and sized.
 - ☐ Proposed basement layout, 1/4" = 1'0"
 - ☐ Elevations, 1/4" = 1'0"
 - ☐ Building section & details as needed
 - ☐ Gas piping plan
- ☐ Site plan must be drawn 1" = 10'0" or larger on unlined or graph paper no smaller than 11" x 17", with a straight edge.
- ☐ If building is a modular home, it must have current ANSI number.
- ☐ Floodplain Development Permit Application. Visit FEMA.gov to view Flood Insurance Rate Map (FIRM).
- ☐ Fire Inspection
