NOTE FROM THE MAYOR

Just a short update on the sewer/water project. We're approaching the half way point. The work on Main Street will continue next spring; we had to move off the highway by Oct. 15th, federal rules say we can't tear up state or federal highways after that date.

We are encountering more problems than expected concerning unmarked lines in town. We have found that some lines aren't where they were expected to be and they feed houses that make no sense. If you have not received notice that your water will be off and you lose water anyway, we hit a line that we didn't know about and we are working as fast as possible to get your water back on. Please be aware that we will never leave your water off over-night. If your water is off for more than a couple of hours, please call the city office and report it, we may not be aware that the outage affects your house. I'm sure you can all understand that with a system as old as this, there are unforeseen problems that will require all involved to improvise as we go along. The best part of this whole project is that when finished, the city will know where every line and valve is and we will be able to maintain the system much easier than in the past.

Ann Louise Snell Garbett.

Ann Louise Snell Garbett 79, passed away Oct. 15, 2015, in Provo, Utah. She was born Sept. 26, 1936, in Eureka, Utah, to Gilbert Edmond Snell and Ellen "Helen" Davies Snell. She grew up in Eureka and attended Eureka schools, where she met her future husband, David. She graduated from Tintic High School.

Ann was the fourth generation in a family of Utah miners, but she always made sure her family knew they were her silver and gold.

She married David Garbett on June 7, 1957, in Eureka. Their marriage was later solemnized in the Manti LDS Temple. Ann was a lifelong member of The Church of Jesus Christ of Latter-day Saints and served in many callings, including the stake Primary presidency. She loved children, and some of her happiest times were spent teaching Primary and caring for children in the nursery.

As a child, Ann taught herself to play the piano. Her motto was, "You can do anything you set your mind to if you try hard enough." Many hours in her home were spent with her family singing around the piano while David played guitar.

She attended Brigham Young University in Provo, after which she taught school in a one-room schoolhouse in Callao, Utah, for two years.

Creativity and a love for sewing led Ann to spend much of her life sewing quilts with many of her cherished friends. She enjoyed helping with humanitarian projects in her LDS ward, and she had a special talent for turning piles of "scraps" into beautiful quilts that have been sent to needy people around the world to make them feel warm and loved. After retiring as a secretary at Dugway Proving Ground, she opened a quilt shop with two of her dear friends. She had just completed her final quilt a few hours before suffering the stroke that hospitalized her on Oct. 8.

Ann is survived by her husband, David; daughters Sue Ann (Weldon) Wardle and Jolene (Brett) Wall; sons Darrell (Tori) Garbett and Gaylon Garbett; 11 grandchildren; 14 great-grandchildren; and one sister, Bonnie England. She was preceded in death by her parents; sisters Norma Fletcher and Helen Delilah Snell; brothers Edward Snell and Donald Snell; and four grandsons, Joshua Wall, Preston Wall, Trevor Wardle and Thomas Justin Miles.

Funeral services were held at the Eureka Ward LDS Chapel at 11 a.m. on Wednesday, Oct. 21.





ORDINANCE NO. 05-14-2013-2

AN ORDINANCE ESTABLISHING WINTER PARKING RESTRICTIONS ALONG ALL CITY STREETS WITHIN THE EUREKA CITY LIMITS.

Be it ordained and enacted by the council of the City of Eureka, State of Utah as follows: SECTION A - DEFININTIONS:

For the purpose of this section, "City Street" shall be defined as being from curb to curb or, being property line to property line.

SECTION B - STATEMENT OF PURPOSE:

It is the purpose of this ordinance to promote the public health, safety, and general welfare of the citizens of this community by preserving our ability to plow the winter snows and keep our roads safe for all to enjoy.

SECTION C - Unlawful to Park, Leave or Abandon:

It shall be unlawful to park, leave or abandon a vehicle on any portion of a City Street or right of way of a city street beginning November 1 to March 31. No parking at any time if there is any snow accumulation within the travel lanes regardless of date. Vehicles include but are not limited to automobiles, trucks, trailers, mobile homes, travel trailers, boats, buses, ATV's, snowmobiles, or any device used in the transportation of humans, animals, or freight of any kind.

SECTION D - Vehicles Subject to Tow:

Vehicles remaining on City Streets under these conditions are subject to being towed at owners' expense.

SECTION E - Penalty:

A violation of this Section will be considered a Class C misdemeanor.

This ordinance shall take effect immediately upon its passage and posting as provided by law.
