Council Member Haynes made a motion to move back into regular meeting. Council Member Nedreberg seconded. No discussion all in favor moved back into regular meeting 8:58 pm.

DISCUSSION/ACTION ITEMS

Tintic Lodge No. 711 – Special Event Permit Application & Request for Fee Waiver Recorder Bigler said the event will be held on June 11th and the past Councils have waived the \$100 special event permit fee. The Elks have always paid for the park rental of the pavilion and restrooms. Council Member Nedreberg made a motion to waive the \$100 special event permit fee. Council Member Trepanier seconded. No further discussion all in favor motion carried. Council Member Snell brought up a question he was asked at the last recreation meeting. He was told the restrooms at the park were not opened for a recent UTV Utah ride. He wanted to know how to respond to this question. He said this group did not pay for the pavilion or to have the restrooms open. Recorder Bigler said in the past the bottom restrooms have been open, but they are not being maintained any longer and are closed. The restrooms at the snack shack were put in for the recreation department. A fee was put in place so the city would have the money to fix any issue or problems with them. A special event permit is only required if an event is held on public property. Mayor Dever felt if these groups want the city to provide a restroom, they need to contact the city and pay the fee. Council Member Nedreberg agreed. Mayor Dever said if a local business sponsors an event on their property a special event permit is not required it is part of their business. The business license renewal process will need to include a copy of their liability insurance and it will need to show it covers these events. He wants to discuss this further with the Council. Council Member Snell asked if the city needs to provide restrooms for the Ride to Light up Eureka Ride. Mayor Dever said no we do not have the resources to provide them. Recorder Bigler said the organizer brought this up and it appears they expect the city provide the restrooms because the ride is being held to benefit the city. Mayor Dever said he is very grateful to all they are doing but felt this should be the responsibility of the organizer.

Review and Discussion of Eureka City Budget for FY Ending June 30, 2023 Council Member Nedreberg made a motion to move the work meeting from June 6th to the 13th and the regular meeting to the 16th. Council Member Trepanier seconded. No further discussion all in favor motion carried.
